Summary: The U.S. Mission in Brussels is seeking eligible and qualified applicants for the position of Painter to work from the warehouse located in Zaventem.

The work schedule for this position is: Full Time (LE: 38 hours per week, FS: 40 hours per week)

Start date: Candidate must be able to begin working within a reasonable period of time of receipt of agency authorization and/or clearances/certifications or their candidacy may end.

Supervisory Position: No

Duties: Provides general painting services for all US Government owned or leased properties. Installs carpet tiles and other types of flooring materials that do not require the use of power tools. Hangs wall paper and replaces ceiling tiles.

Qualifications and Evaluations

Education: Secondary / Trade School with a specialty in painting.

Requirements:

EXPERIENCE: One year of journeyman painting experience.

JOB KNOWLEDGE: Must be able to judge if proper precautions were taken to prevent collateral painting damage to furniture, carpet and other-non-painted surfaces.

Evaluations:

LANGUAGE: Level 3 (Good Working Knowledge) Speaking/Reading/Writing of French or Dutch is required. Level 1 (Basic Knowledge) Speaking/Reading/Writing of English is required. (This may be tested.)

SKILLS AND ABILITIES: Must be able to mix paint colors, be able to understand basis painting instructions and have a valid B+ driver's license for cars.

Qualifications: All applicants under consideration will be required to pass medical and security certifications.

* IMPORTANT: Applicants who claim status as a preference-eligible U.S. Veteran must submit a copy of their most recent DD-214 (“Certificate of Release or Discharge from Active Duty”), equivalent documentation, or certification. A “certification” is any written document from the armed forces that certifies the service member is expected to be discharged or released from active duty service in the armed forces under honorable conditions within 120 days after the certification is submitted by the applicant. The certification letter should be on letterhead of the appropriate military branch of the service and contain (1) the military service dates including the expected discharge or release date; and (2) the character of service. Acceptable documentation must be submitted in order for the preference to be given.

** This level of preference applies to all Foreign Service employees on LWOP and CS with re-employment rights back to their agency or bureau.
