Summary: The U.S. Mission in Brussels is seeking eligible and qualified applicants for the position of Warehouse Worker.

The work schedule for this position is: Full Time (LE: 38 hours per week, FS: 40 hours per week)

Start date: Candidate must be able to begin working within a reasonable period of time of receipt of agency authorization and/or clearances/certifications or their candidacy may end.

Supervisory Position: No

Duties: Performs various types of warehouse duties. Moves and sorts items, loads and unloads vans, trucks, or containers, moves pallets using hand trucks, or other equipment. Cleans, organizes, and re-sorts stock areas for proper, safe and organized storage. Delivers/picks up supplies, furniture, or equipment from Tri Mission residences or offices.

Qualifications and Evaluations

Education: Lower secondary school diploma necessary.

Requirements:

EXPERIENCE: 6 months experience in private or government warehouse as storekeeper or warehouseman.

JOB KNOWLEDGE: Good knowledge of procedures and techniques for safely packing, opening, repacking and storage of U.S. Government property. Good knowledge of how to handle and safely lift heavy items, as well as how to load and stack fragile items.

Evaluations:

LANGUAGE: Level 2 (Working Knowledge) speaking/Reading/Writing of English is required. Level 2 (Working Knowledge) speaking/Reading/Writing of French or Dutch is required. (This may be tested.)

SKILLS AND ABILITIES: Must be able to communicate effectively with English-speaking personnel, and must be able to understand and complete English-language forms utilized in the storage, delivery and issuance of supplies. Ability to lift and move up to 60lbs (30kg). Must possess a Class B driver's license. Ability to use lifting equipment i.e. hand trucks.

Qualifications: All applicants under consideration will be required to pass medical and security certifications.

EQUAL EMPLOYMENT OPPORTUNITY (EEO): The U.S. Mission provides equal opportunity and fair and equitable treatment in employment to all people without regard to race, color, religion, sex, national origin, age, disability, political affiliation, marital status, or sexual orientation.

Benefits: Locally Employed Staff, including Members of Household (MOHs), working at the U.S. Mission in Brussels receive a compensation package that includes benefits such as hospitalization insurance, life insurance, and extra-legal pension.

Therefore, it is essential that these applicants accurately describe their status on the application. Failure to do so may result in a determination that the applicant is not eligible for a hiring preference.

- (1) AEFM / USEFM who is a preference-eligible U.S. Veteran*
- (2) AEFM / USEFM
- (3) FS on LWOP and CS with reemployment rights **

* IMPORTANT: Applicants who claim status as a preference-eligible U.S. Veteran must submit a copy of their most recent DD-214 (“Certificate of Release or Discharge from Active Duty”), equivalent documentation, or certification. A “certification” is any written document from the armed forces that certifies the service member is expected to be discharged or released from active duty service in the armed forces under honorable conditions within 120 days after the certification is submitted by the applicant. The certification letter should be on letterhead of the appropriate military branch of the service and contain (1) the military service dates including the expected discharge or release date; and (2) the character of service. Acceptable documentation must be submitted in order for the preference to be given.

** This level of preference applies to all Foreign Service employees on LWOP and CS with re-employment rights back to their agency or bureau.
