Summary: The U.S. Mission in Brussels is seeking eligible and qualified applicants for the position of Rover Administrative Assistant.

The work schedule for this position is: Full-time or part-time schedules possible, depending upon preference of selected candidate. A minimum of 20 hours per week is required.

Start date: Candidate must be able to begin working within a reasonable period of time of receipt of agency authorization and/or clearances/certifications or their candidacy may end.

Supervisory Position: No

Duties: This position is a rover assistant. The incumbent provides office management assistance to various sections when there is a staffing need. Duties vary based on location and nature of assignment.

Qualifications and Evaluations

Education: Completion of secondary school.

Requirements:

EXPERIENCE: One year of clerical/secretarial experience.

JOB KNOWLEDGE: Critical thinking and organization are a must. Knowledge of Microsoft Word, Excel Powerpoint, Publisher, OneNote, Adobe PDF, typing skills, and general office equipment knowledge.

Evaluations:

LANGUAGE: Level 4 (Fluent) Speaking/Reading/Writing of English is required. (This may be tested.)

SKILLS AND ABILITIES: Business communication skills including drafting routine correspondence; knowledge of Microsoft Office; flexibility in adapting to a non-routine workday with numerous interruptions; general office and administrative skills.

Qualifications: All applicants under consideration will be required to pass medical and security certifications.

EQUAL EMPLOYMENT OPPORTUNITY (EEO): The U.S. Mission provides equal opportunity and fair and equitable treatment in employment to all people without regard to race, color, religion, sex, national origin, age, disability, political affiliation, marital status, or sexual orientation.

Benefits: Locally Employed Staff, including Members of Household (MOHs), working at the U.S. Mission in Brussels receive a compensation package that includes benefits such as hospitalization insurance, life insurance, and extra-legal pension.

Therefore, it is essential that these applicants accurately describe their status on the application. Failure to do so may result in a determination that the applicant is not eligible for a hiring preference.

- (2) AEFM / USEFM

(3) FS on LWOP and CS with reemployment rights **

* IMPORTANT: Applicants who claim status as a preference-eligible U.S. Veteran must submit a copy of their most recent DD-214 (“Certificate of Release or Discharge from Active Duty”), equivalent documentation, or certification. A “certification” is any written document from the armed forces that certifies the service member is expected to be discharged or released from active duty service in the armed forces under honorable conditions within 120 days after the certification is submitted by the applicant. The certification letter should be on letterhead of the appropriate military branch of the service and contain (1) the military service dates including the expected discharge or release date; and (2) the character of service. Acceptable documentation must be submitted in order for the preference to be given.

** This level of preference applies to all Foreign Service employees on LWOP and CS with re-employment rights back to their agency or bureau.

How to Apply: All candidates must be able to obtain and hold a Top Secret clearance. Applicants must submit a Universal Application for Employment (DS-174) which is available on the Mission’s internet site.
